

2021 Swimming Pool Registration Renewal(Short Form) For Previously Registered Residents

This form may be used by residents that previously registered for pool passes and have previously issued passes (see reverse for whom may use this form and how to request minor changes to passes). Previously issued pool passes should be retained by the owner, as renewal stickers will be mailed to residents to affix to existing passes unless noted below. Passes allow seasonal use of the pool and must be given to the lifeguard at the entrance to the pool upon entering for all members. You must sign in/out for each visit. It is the responsibility of Community Association members to ensure that passes are used only by eligible full-time residents in your home and in accordance with the current Pool Policy and Rules published on www.leelandstation.org.

Who May use this short form?

- Residents that previously registered for, and have previously issued, pool passes for family members and two Guest Passes per residence.
- Residents that have minor changes to family pool passes (see what minor changes may be made below)
- If you rent your home, you must continue to complete the long-form, assign pool privileges to your tenants, and include a copy of the lease.

What constitutes a minor change?

- New full-time residents such as the birth of a new family member, adoption of a new family member or parent(s) now live with you. Provide name and birth date of new resident(s) in the change section of the form.
- A child has or will turn 12 years old prior to Labor Day of the current year.
- To correct an error on previously issued passes.

Lost Passes?

A replacement fee of \$5.00 per pass will be assessed for lost passes, which must accompany this form when submitted. This fee applies to a family member and guest passes. Payment may be made by check payable to Leeland Station Community Association. No charge will be incurred for the replacement of passes in poor condition through fair wear and tear as judged by the issuing official. Please provide the name(s) and birth date of the person(s) for which the replacement passes are required in the change section of the form and turn in damaged passes.
